Message from the President

I hope everyone had a Merry Christmas for 2018 and a Happy New Year to start off 2019. I can say the Caroline Historical Society, Inc. (CHS) had a very active and productive year for 2018. CHS sponsored several major events and participated in many community activities during the year that helped promote CHS. Special events included the Bowling Green "Clean Sweep", Earth Day at Fort A. P. Hill, exhibits celebrating the 100th anniversary of World War I and the 75th of World War II, an enjoyable special 50th anniversary celebration of CHS with a USO Big Band Dance at Town Hall, art exhibition of nationally known local artist Joe Umble, and the Holiday Open House and a Local Author Book Signing. Busy year! In addition, CHS received many unique historic items of interest to further expand our collection. Be prepared to see and hear about some of these donated items at our January membership meeting. This adds up to promoting CHS, education of local history, and increasing membership. CHS will be changing exhibits in January 2019 and the new exhibits may include vintage items from Caroline County's past in the areas of schools and education, businesses, transportation, churches, law enforcement, farming, RF&P Railroad, and other interesting artifacts. Although this was a good year in many ways, it was also sad in the loss of several long-standing dedicated members. Our deepest respect and sympathy are again extended to the families of our dear departed friends and members, they are missed.

Update—Old Jail Project: One goal of CHS is to have the county owned Pauly Jail, built in 1900, placed on the Virginia Landmarks Register and the National Register of Historic Places. Permission for CHS to proceed with the application process was granted by the county in 2018. The Preliminary Information Form (PIF) was completed in December 2018 and sent to the Virginia Department of Historical Resources (VDHR) for their Internal Evaluation Committee to review. Once reviewed and approved, the PIF goes to the State Review Board for further consideration. A decision on the PIF.is expected by March 2019. Approval by VDHR would allow a formal application to be submitted for placement on the Virginia Landmarks Register and the National Register of Historic Places. Final approval to be placed on the National Register of Historic Places is controlled by the National Park Service. A lengthy process that will hopefully open the door for grants to rehabilitate the structure and eventually open to the public.



The program for our January membership meeting will be "Show & Tell" so bring an old artifact with a story and share it with membership. The program originally planned for our meeting will take place at the April 28th meeting.

One of the items on the agenda for our January meeting will be the discussion of the changes to the Caroline Historical Society, Inc.'s bylaws. The officers and board members have reviewed the changes and will be recommending approval to the membership at the meeting. The bylaws were changed in format only and not in the wording or intent. The sections are better organized and easier to follow.

As stated in the bylaws, the election of CHS officers and board members are required every 2 years on the date of the annual meeting. It is that time again and the election will take place at our January 27, 2019 membership meeting. The slate of officers and board members being recommended by the Nominating Committee is as follows:

After receiving a variety of historical materials from the now defunct Caroline Museum and a donation of 71 bound volumes of the Caroline Progress dating from 1951-2009, our storage space is filled to overflowing. We are assessing the holdings that we have cataloged through the years and are carefully applying our commitment to "protect and preserve" historical items of Caroline history. In doing so we have found that a number of books which have been around since the inception of CHS, and which we have called our Reference Collection, are not pertinent to our focus on local history and when we do need to do research on an item the internet provides an immediate and comprehensive amount of meaningful information. Caroline Historical Society, Inc.'s 2018 Annual Award


Caroline Historical Society's Annual Award is presented to an individual(s), organization, group, business, or government entity that has generously donated their time and efforts to preserving and promoting Caroline County history. For the year 2018, Dale Brittle was nominated and selected by the Annual Awards Committee to receive the Caroline Historical Society Annual Award. This is the 18th time this award has been presented. Her untiring efforts to research, preserve, publish, exhibit, highlight, and promote the history of Caroline County truly show she certainly deserves this award.

Dale Brittle

Dale Nye Larkin was born in 1943, during World War II. Her father served in the U.S. Army from 1943 until 1945 in the 9th Army Air Force. Dale lived in the Bronx and her family moved to Bergen County, New Jersey, when she was 10. She completed her senior year at Mahwah High School in 1960.

Dale enrolled in Radford College (now Radford University) and obtained a B.S. degree in biology. Her father insured all four of his children received college degrees. She continued to attend Radford and earned a master's degree in counseling. This is where she met her future husband, Gilbert Brittle, who attended Radford and obtained his master's degree in public school administration in 1965. Gilbert and Dale were married in 1966, while Gilbert was principal of Caroline High School.

For two years, Dale taught biology in Douglas Freeman High School in Henrico County and then came to Caroline to teach and work as a high school counselor. Dale became a licensed professional counselor and served on the Virginia Counselors Association board for 30 years. She was frequently recognized for her achievements. Dale was director of guidance service at Caroline High School for more than 20 years and retired after 33 years of service in Virginia public schools.



Dale volunteers to work each month in the Sidney King Arts Center and Caroline Historical Society. Volunteers assist in keeping the building open three days per week, so visitors may view the arts center and Caroline County history displays.

In 2014, when the Sidney King Arts Center was preparing to open, the Historical Society display cases had to be made ready. The display cases were organized to present Caroline history with exhibits about Bowling Green, Caroline schools, post offices, railroad history, baseball, Camp

A. P. Hill, hand tools, and law books with early references to the county. It took a long time to gather the artifacts and books, to label these items, and to prepare documentation for each exhibit. Plastic sleeves provided the viewer with one-page summaries for each display. Dale Brittle helped Bernard Collins prepare the displays and assembled related notebook binders on each exhibit. Supportive materials included articles from newspapers, magazines, and pictures. She visited a variety of sites in the county and took pictures which were added to many binders.

In 2017, the Commonwealth of Virginia and Caroline County began a year and half period a commemorating the anniversaries of World War I and World War II, highlighting Caroline veterans who served in the armed forces. Wayne Brooks changed the display cases to reflect these periods in history relative to the county. The exhibition included photographs, articles, letters, medals, weapons, and memorabilia loaned by Caroline residents. Dale Brittle stepped in again. She helped Wayne with documentation reproduced photographs for visitors' viewing.

Women have certainly made great contributions to our country. In 1987, Congress designated March as National Women in History Month supported by the Presidents of the United States. Dale realized many women in Caroline deserved to be recognized and remembered. She began a "Women in History" project in 2014, supported by the Caroline Historical Society. She researched information and had articles published in *The Caroline Progress* to recognize the past achievements of women in Caroline. These included—in 2015—Mary Adams, Helen Hull Jacobs, Mae Brooks, and Kathy Hancock. In 2016—Dorothy Hamm, Virginia Wright Durrett, Clara Lee Smith and Dorothy Roy. In 2017—Captain Sally Thompkins, Cleopatra Coleman, Carolyn Lane, and CHS Collection Committee volunteers Carolyn Roth, Kathy Burchell, and Mandy Young. In 2018—Carolyn Davis, Leeanne Laden, Pauline Campbell, and Kay Brooks. One woman for each week in March was highlighted.

Dale has worked on many projects for the Society, but one of her favorites was researching Rosenwald schools in Caroline County. At the end of the 19th century, Julius Rosenwald established funds to assist African-American communities build schools. Nine were built in Caroline County. In 2015, Dale presented a paper on her findings at the J. S. Reynolds Community College's "Virginia School Initiative." Several articles have since been written and have appeared in *The Caroline Progress* and the CHS Newsletter.

For the year 2018, Dale Brittle was nominated and selected to receive the Caroline Historical Society Annual Award. This is the 18th time this award has been presented. Her untiring efforts to research, preserve, publish, exhibit, highlight, and promote the history of Caroline County truly show she certainly deserves this annual award.
