Ms. Young needs your help in finding out where these homes were located, who lived in the house, and history (age) of the structure. As a part of her presentation, CHS is asking members, friends, and guests to bring pictures of older homes in Caroline and allow CHS to scan or copy them as a part of this ongoing project of collecting and preserving our county's past. It is so important for our organization, and we as individuals, to make every effort to reach out to others and ask they share family heirlooms, artifacts, photographs, and other items related to Caroline County history. The CHS mission is to preserve our local history for the benefit and education of our future generations. May future generations carry forth the same principles and ideals as CHS.

The second part of the meeting will be another one of our fun "show & tell" meetings. ### Who Was John Penn from Caroline County, Virginia?

This country boy from rural Caroline County, not known by many, established himself as a true patriot, advocating freedom from the British rule prior to and during the Revolutionary War. Caroline County can be proud of its native son's patriotism, courage, personal sacrifices, and overall accomplishments in creating and signing the documents to free the United States of American from British rule.

John Edmund Penn was born in Caroline County, Virginia, on May 17, 1741, near Port Royal, Virginia. He was the son of Moses Penn and Catherine Taylor Penn and their only child. He

attended local schools in his early years. As he turned 18 years of age, his father passed away and John studied law with his well-known uncle, Edmund Pendleton, of Caroline County. In 1762, after working with several of Virginia's finest lawyers, including his uncle, John Penn became licensed to practice law in Virginia. On July 28, 1763, he married Susannah Lyne of Caroline. This marriage brought forth two children over the years, William (who never married), and a daughter, Lucy. Lucy Penn (daughter) married John Taylor, another famous individual from Caroline County, who was taught law by the famous Edmund Pendleton, just like his father-in-law, John Penn.

After 12 years of practicing law in Virginia, John Penn and his family moved close to Williamsboro, Granville County, North Carolina. His reasons for moving appear to have been political as he had strong feelings against the British rule. Penn quickly became popular and recognized as a leader. In 1775 he was elected to the North Carolina Provincial Congress and to the Continental Congress in which he served until 1780. He was a member of the North Carolina delegation for the 1776 signing of the Declaration of Independence and one of North Carolina's signers of the Articles of Confederation, while serving on the Board of War. As with other delegates to the Continental Congress, Penn did not receive a salary, only occasional reimbursement for travel expenses. This lack of revenue caused economic stress on his family and business affairs. In 1781, within a year after retiring from Congress, Penn served as the "Receiver of Taxes" for North Carolina before finally retiring in 1784. John Penn, formerly of Caroline County, Virginia, passed away in 1788 at the age of forty-seven and was buried on his estate near Island Creek, in Granville County. His remains were relocated to the Guilford County National Park in 1894, to be alongside his fellow delegate, William Hooper.

Our John Penn, not to be confused with the grandson of William Penn, who was famous in Pennsylvania, should be remembered for his major accomplishments in creating the United States of America. To briefly summarize his accomplishments:

- 1. Served in the Continental Congress for six years (representing North Carolina).
- 2. Signed the Declaration of Independence.
- 3. Signed the Articles of Confederation.
- 4. Signed the Halifax Resolves (the North Carolina Constitution).
- 5. A "major influence" in North Carolina during the final years of the Revolutionary War.
