# From the President

The Caroline Historical Society, Inc. (CHS) and Historic Port Royal (HPR) have agreed to hold a "Joint" meeting on August 14, 2022, at 2 p.m. in the Caroline Community Services Center at 17202 Richmond Turnpike, Milford, Virginia 22514. This means CHS WILL NOT have our regular membership meeting scheduled for July 24, 2022. I apologize for any inconvenience, but the proposed "Joint" meeting will include an important program that could help enhance tourism in Caroline County that could benefit both organizations and Caroline County overall.

The program for the August 14, 2022, meeting will include a presentation by the Virginia Lewis & Clark Legacy Trail, Inc. (VLCLT) on the proposed Lewis & Clark Trail planned for various locations in Virginia. Stakeholders in the trail project have been inspired by the recent financial support from the Virginia General Assembly for trail signage. VLCLT members have held meetings with local historical society representatives to gather information on including certain sites in Caroline County on the proposed Lewis & Clark Trail.

The Lewis and Clark Expedition, also called the Corps of Discovery Expedition, was the idea of President Thomas Jefferson. Congress approved funding for the expedition for the purpose of surveying the newly acquired 827,000 square miles purchased from France. This deal with France was called the "Louisiana Purchase" and cost the United States 15 million dollars. The expedition took approximately two years (1804-1806) and was an immense success. Money well spent.

The Lewis & Clark team was composed of Captain Meriwether Lewis (1774-1809) and Lieutenant William Clark (1770-1838), both being Virginia born, became good friends while serving in the military together. William Clark was born in Caroline County, west of Ladysmith and became close friends with Thomas Jefferson when his family moved to the Charlottesville area. Meriwether Lewis was born not too far from Charlottesville in the small community of Ivy.

The purpose of the Lewis & Clark Trail through Virginia is to honor Virginia born Meriwether Lewis and William Clarke for their exploits while designating and promoting historic points of interest connected to their lives and travels. Once the historic locations are identified, signage, maps, brochures, and promotional materials must be funded to complete the program. It may take several years to complete but through cooperative efforts between the Virginia General Assembly, Virginia Department of Historic Resources, Virginia Department of Transportation, Virginia Department of Tourism, VLCLT, various organizations, grants, and funding from local counties, cities and towns will be successful. The result will not only increase tourism but clearly provide another method to promote local, state, and national history through visual objects, signs, and written information.

### **CHS Annual Award 2022**

Congratulations Bernard! At the April 24, 2022, CHS Quarterly Membership Meeting, it was my honor and pleasure to present the "Well Deserved" **2021 CHS Annual Award** to James Bernard Collins for his dedicated service to preserving and promoting our local history. Bernard has always enjoyed history, a retired Lt. Colonel of the United States Air Force, he graduated from the University of Richmond with a degree in history. Bernard has been a Life Member in the Caroline

Historical Society since 2008. Even before becoming a Life Member with CHS, Bernard has always been active with volunteering for CHS on days at the museum and for special events. For many years he would set up a table at the Harvest Festival for the historical society or for Earth Day at Fort A. P. Hill. ## **Recent Donations**

CHS was truly fortunate to have received several vintage photos from Ms. Frances Webb Burch, former resident, now living in Richmond, Va. The early photos are of the former Webb family



Above is the home of Dr. Charles S. Webb, Sr., on Main St. Bowling Green in mid 1890s. Pictured in the photo, are Dr. Webb, (1846-1935), his first wife, Ella (1857-1898), and their daughter, Margaret.

home located on the westside of Main Street in Bowling Green, Virginia, across the street from the Old Courthouse. Ms. Burch's father was Dr. Charles Shepherd Webb, Jr. (1904–1990) and her mother was Fannie Taliaferro Webb (1905-2003). Dr. Charles S. Webb, Jr., and his brothers William and Robert were born in the house shown in these pictures.



The same Webb home, pictured above and to the right, is on the left side of the photo and was located on Main St. adjacent to and north of the Bowling Green Hotel. The white building on right side of the picture was once used for the local post office, apartments, and offices both structures were demolished when the Southside Bank was built, now a gun shop. Pitts and Manns Real Estate building (old movie theatre) is to the right of the white building.

#### **Point Eastern Post Office**

A local resident, Joe Pitts, stopped by a few weeks ago to donate the below picture of his maternal grandparents, Luther Reins Christian (1868-1940) and Daisey Blanton Christian (1880-1946). Luther and Daisey Christian were married in 1905 and lived in the below pictured house while operating the Point Eastern Post Office out of their home. The post office, general store, and home were located at the intersection of Routes 600 and 601 in the southeastern part of the county.

"Point Eastern," a two-story frame home with eight rooms, was built by Edward Christian (1818-1892), father of Luther Christian, around 1860. Edward Christian, born in Hanover County, moved to Caroline County in 1852 and married Martha Ellen Mason (1839-1917) in 1857. The Point Eastern Post Office was created on February 16, 1866, when the post office, located at White Chimneys, was changed to the Christian home at Point Eastern. White Chimneys was located south of Pendleton School on the westside of Route 301. Edward Christian became postmaster of Point Eastern Post Office in 1866. He served as postmaster for 26 years. His son, Luther Christian inherited the house after his father's death and became postmaster in 1937. Luther Christian served as postmaster for 47 years and his wife Daisey, served as postmistress for one year (1940). The members of the Christian family served a total of 74 years in the position of postmaster or postmistress at the Point Eastern Post Office. Thank you, Joe Pitts, for donating the photo.

## **Visitors from North Carolina**

On Sunday, June 19, 2022, I had the pleasure of meeting the three gentlemen pictured with me in the below photo. They were in Caroline County/Bowling Green, traveling from North Carolina, for a long overdue visit with friends and relatives. As youngsters, they visited family members in Bowling Green many times. During the tour of the historical society and the Sidney King Arts Center, the conversation included stories of their visits "back in the day." Alan, Doug, and Scott Banks are the grandsons of the late Floyd Borkey (1895-1981) and Margaret Borkey (1908-1992). Margaret Borkey was the daughter of Edwin Sommerville Coghill, son of Edwin Ruthven Coghill

(1842-1925), former Clerk of the Court.

Edwin Ruthven Coghill is Alan, Doug, and Scott's great-great grandfather. Mr. Coghill served as a sergeant in Company "E" of the 30<sup>th</sup> Virginia Infantry Regiment during the War Between the States. Following the war, he served as Clerk of the Court for 30-plus years. After his long run as Clerk, his son E. S. "Eddie" Coghill (1875-1953), who served as Deputy Clerk, followed in his father's footsteps, and became Clerk of the Court until his retirement.

Pictured below is one of the gifted items from the Presgraves family, it is one of the best single items ever donated to the Caroline Historical Society, Inc. Over the past several years CHS has received donations from James "Jim" Presgraves related to his Caroline families who lived in what is now Fort A. P. Hill. Jim was honored last year for his thoughtful donations by being presented with the CHS' Annual Award



for 2020. Sadly, Jim passed away in March of this year. His wife, Betty Presgraves, recently donated to CHS this fantastic hand-woven Presgraves family heirloom (coverlet) measuring seven feet by ten feet. It is a remarkable piece of 200-year-old local history and CHS is fortunate to have it as a part of our collection. The patch shown in the photo contains the following words: "Grown, Shorn, Spun, Woven, Dyed and Finished by Frankie, Dollie, and Betsy Boulware, sisters of Turner, Father of James, Father of Allie, Father of Lucille, Mother of James & John Presgraves Made at "The Walnuts" Caroline County, Virginia 1812(?)
