Correction to the July 2022 Newsletter

In the July 2022 CHS newsletter, I incorrectly identified the lady in the photograph below as Ella Webb (1857-1898), Dr. Charles Shepherd Webb, Sr.'s (1846-1935) first wife. The lady in the



photo is Dr. Charles Shepherd Webb, Sr.'s second wife, Mary Camper Webb, who was Frances Webb Burch's grandmother. Dr. Webb's first wife, Ella, passed away in 1898. Dr. Webb and Ella Webb's daughter, Margaret Webb, was born in 1889. Dr. Webb remarried in 1900 to Mary Camper. The child in the picture is Margaret Webb, daughter of Dr. Webb and Ella Webb. Mrs. Frances Webb Burch now living in Richmond, Virginia, donated the picture of the Webb family home, formally located on the west side of Main Street in Bowling Green, Virginia, across the street from the Old Courthouse.

Mrs. Burch's father was Dr. Charles Shepherd Webb, Jr. (1904–1990) and her mother was Fannie Taliaferro Webb (1905-2003). Dr. Charles S. Webb, Jr., and his brothers, William and Robert, were born in the house shown in this picture. I apologize to Mrs. Burch for any confusion I may have caused by not identifying the Mrs. Webb correctly. The Webb home was removed many years ago..

Notes on 1918-19 Spanish Flu Pandemic

I was asked if there were any figures on the deaths in Caroline County from the 1918-19 Spanish flu. The world-wide Spanish flu pandemic was estimated to have killed between 20 and 50 million people. From the information researched, state and local officials documented approximately 300 cases of the Spanish flu in Caroline County between 1918 and 1919 with six known deaths.

October Quarterly Meeting

Our program planned for the CHS Quarterly Meeting in October 2022, will be a tour of the historical sites at Fort A. P. Hill to include the old Mica schoolhouse, Liberty Church, The Lodge, and several other points of historic interest. The Fort A. P. Hill Environmental and Natural Resources Division staff has extended an invitation to CHS and Historic Port Royal to visit those remaining historic structures and sites on the military base. Light refreshments will be available. At the time of this newsletter release, details of the exact time and location to meet at Fort A. P. Hill have not been announced. a recent donation to our organization. The painting was from an "anonymous" donor. The painting is of the "Old Mansion" home in Bowling Green, just on the southern edge of the town. The "Old Mansion" originally called "The Bowling Green" was built around 1741 and is privately owned. The local artist was Victorine Collins, and the painting is dated 1971. A welcomed addition to our collection of local artifacts and artwork.

Interesting Facts – Who was Charles Bridges (1672-1747)

Who was Charles Bridges and why was he important in Caroline County, Virginia, history? Charles Bridges, a painter, was born on April 2, 1672, in Northamptonshire, England, where he was christened in the parish of Barton Seagrave and was the son of John Bridges and Elizabeth Trumbull Bridges. He married Alice Flower on August 4, 1687, at Saint Marylebone, near London. His marriage produced at least three children, a son and two daughters. There is no record of when Mr. Bridges became a painter, but it appears he had formal education or training in art. He arrived in Williamsburg, Virginia, in 1733, as a widower, with all three of his children. With letters of introduction, he met James Blair, Lieutenant Governor William Gooch, and William Byrd II. One of his daughters died in Williamsburg on August 24, 1736. After the death of his daughter, Mr. Bridges moved to Hanover County, Virginia. During his stay in Virginia, Bridges completed a handful of documented portraits (not signed) of prominent Virginia families including William Gooch, Mrs. Mann Page II and Child, William Prentis, Augustine Moore, Mrs. Augustine Moore and Child, Mann Page II, John Bolling, Jr., William Byrd's children, and James Blair. His paintings can be found at Washington and Lee University, the Colonial Williamsburg Foundation, and the Virginia Historical Society. He became the first documented painter in Virginia from 1735 to 1744. Charles Bridges, although known for his portraits, painted non-portraits, as was the case with other colonial painters. In 1739, the magistrates of Caroline County hired him to paint a mural of the King's Arms on the interior wall of the first courthouse located in an area between Kidd's Fork, Ideal, and Shumansville. The county paid Charles Bridges 1,600 pounds of tobacco for his artwork. It is believed this "first" official courthouse was built around 1731-32. Records indicate the Bridges' painting and the courthouse were damaged during the fire of 1742 which destroyed the jail. Unfortunately, the true fate of the Bridges mural is unknown, a copy or facsimile does not exist. It was several years before additional lands was purchased and the courthouse rebuilt. The courthouse building would go through several more relocations before being constructed around 1830 in Bowling Green. Charles Bridges returned to England in 1744 and died in 1747.




